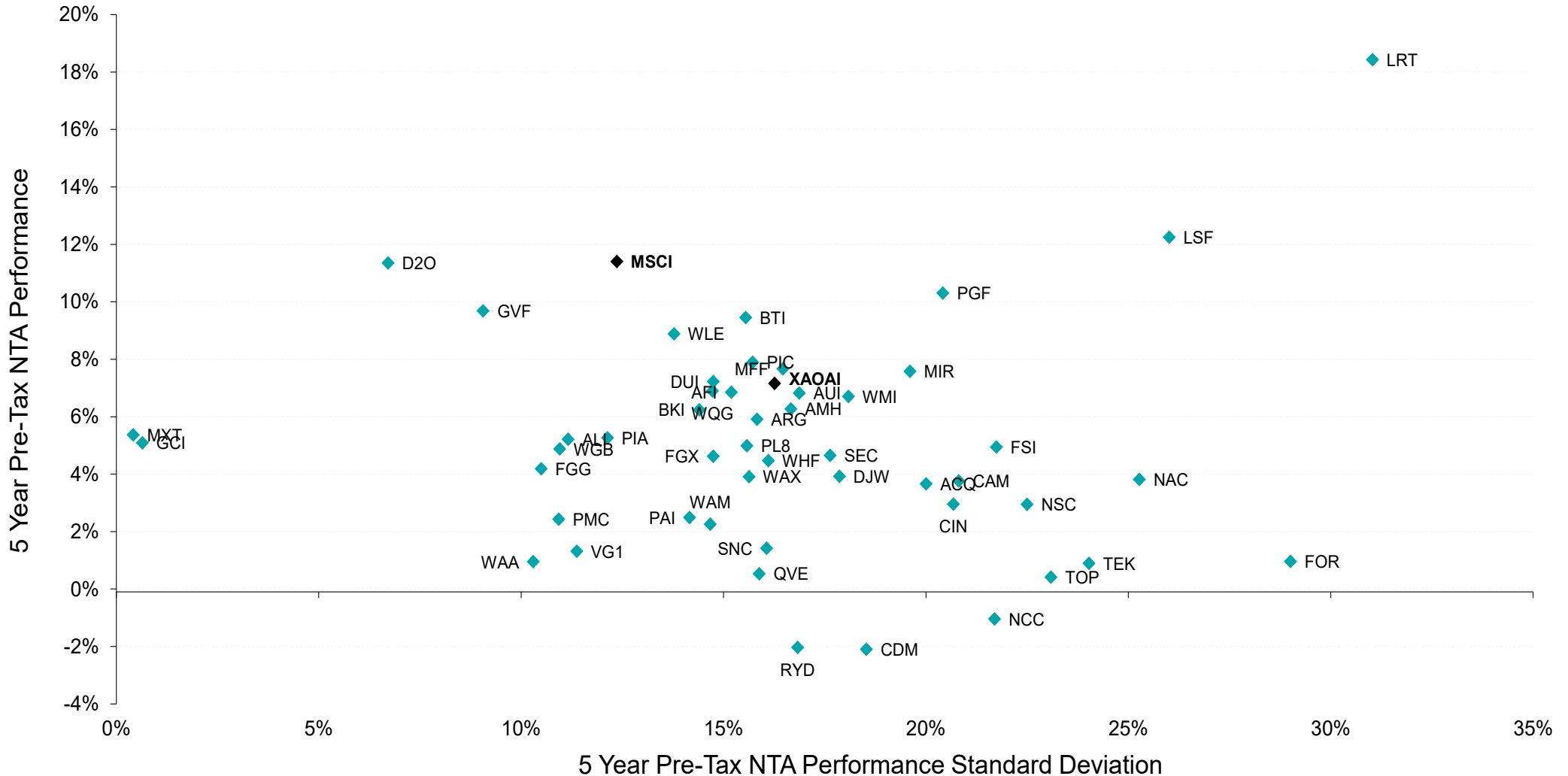

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation

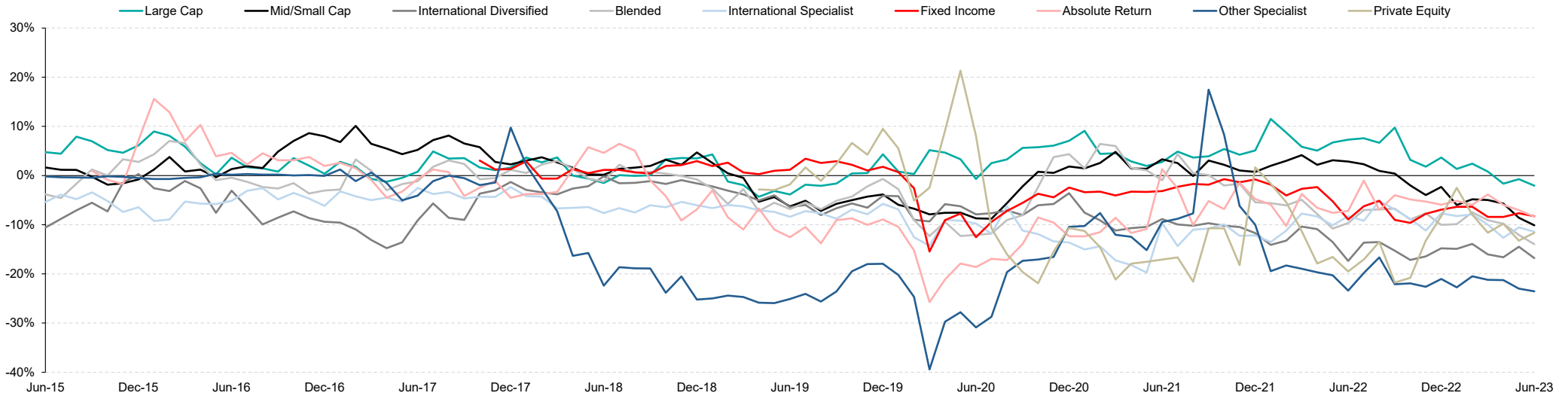

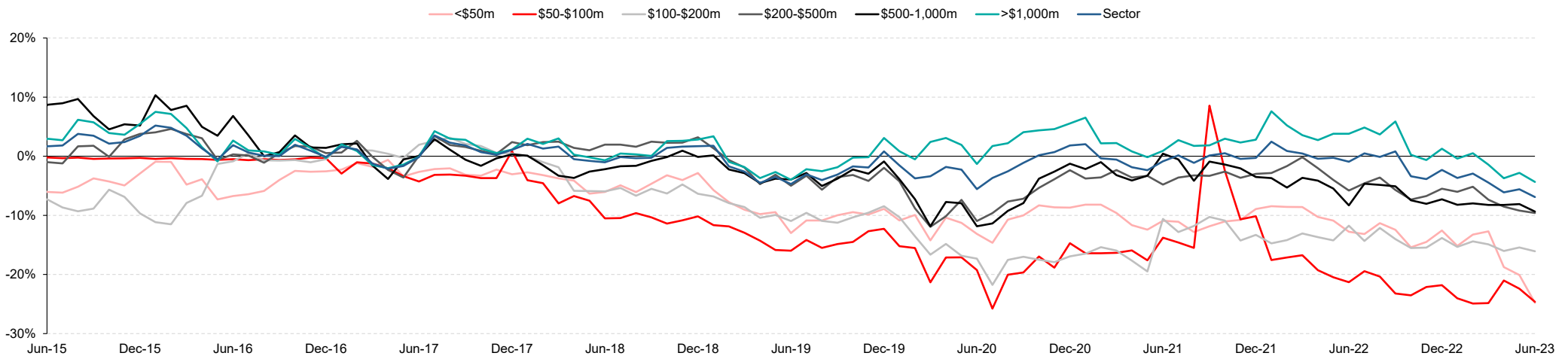

Chart 4: Premium/Discount by Market Capitalisation Band (Mkt Cap Weighted)

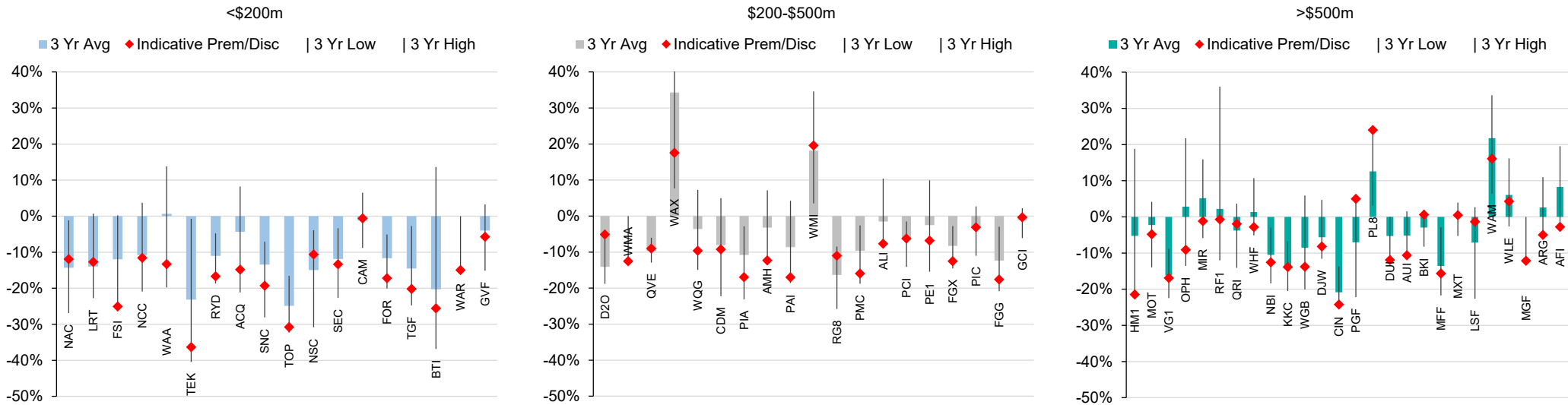

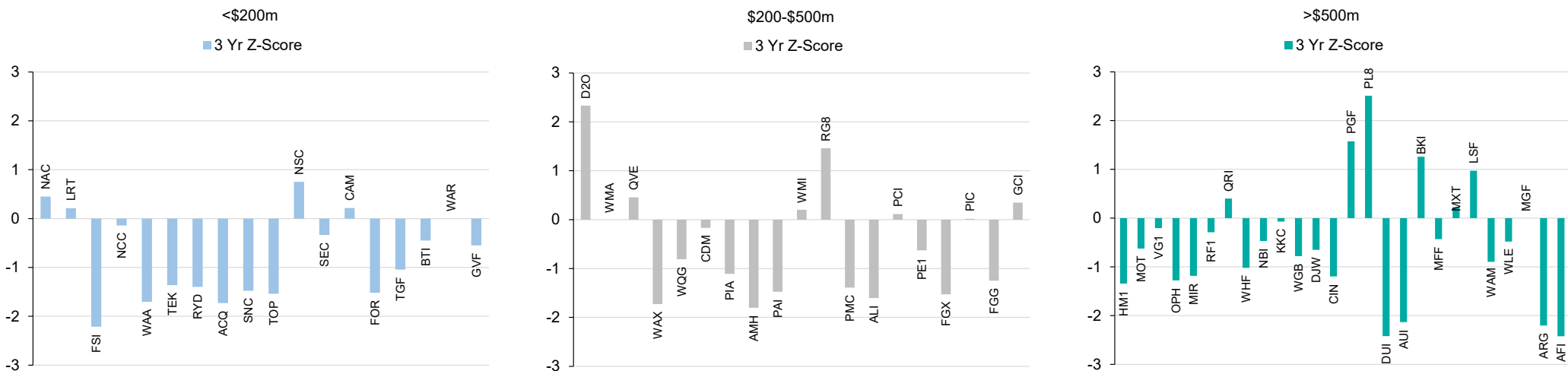

### Chart 5: Premium/Discount Relationship Across Market Capitalisation Band



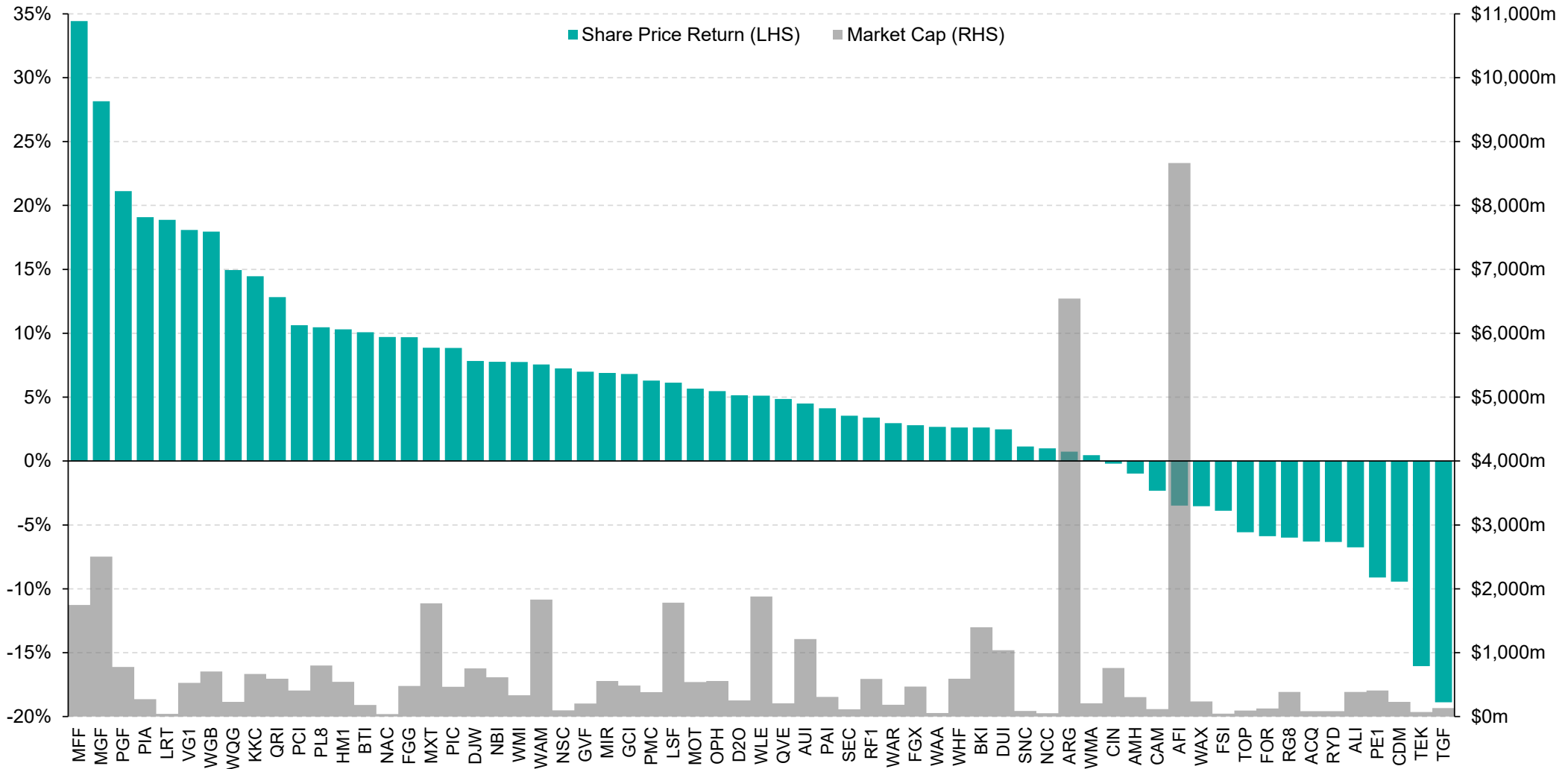
