MGF Conversion in Place

The **Magellan Global Fund (Closed Class) (MGF)** was suspended from quotation on the 11th of July as part of the implementation of the fund's conversion process to open class units. As previously flagged by the manager, the conversion permanently addresses the trading discount to net asset value and will provide investors more flexibility as to how they can enter and exit the fund.

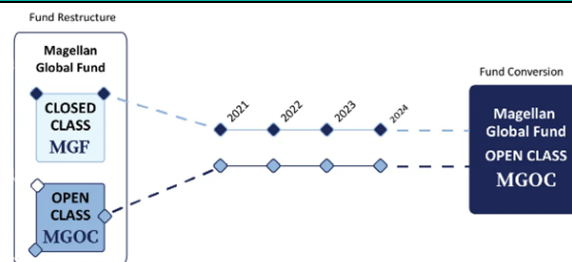

Upon conversion, each MGF unitholder will receive units in the **Magellan Global Fund (Open Class) ETF (MGOC)** based on the ratio of net asset value between the two funds on the conversion calculation date, being the 19th of July. Currently the conversion ratio sits at 0.736 MGOC units per MGF, noting any fractional entitlements will be rounded to the nearest whole number. The conversion of units will be implemented on the 22nd of July, with newly issued open class units to commence trading on the 23rd of July.

QVE Consideration Announced

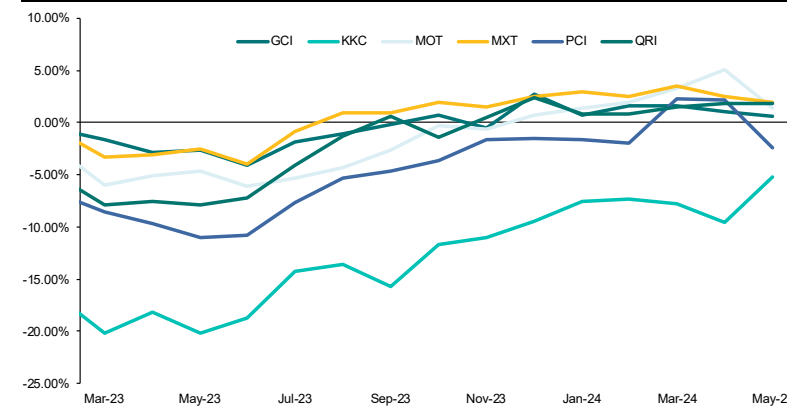
Now that the scheme between **QV Equities Limited (QVE)** and **WAM Leaders Limited (WLE)** has become legally effective, QVE has made an announcement as to the scheme's consideration.

- **Scrip Consideration:** 0.7323 WLE shares for each QVE share held (default consideration)
- **Cash Consideration:** \$0.9576 for each QVE share held

PCI Grows the Book

The **Perpetual Credit Income Trust (PCI)** announced last week both a placement and unit purchase plan (UPP) at \$1.10, being a 4.8% discount to PCI's closing price before the offer was announced. The placement offer successfully raised \$66.2 million, with the UPP remaining open until the 6th of August. The announced capital raising by PCI reflects an increased appetite from investors to participate in credit markets, given elevated yields across the credit quality spectrum. The trust remains diversified across sectors, with around half of the portfolio held in corporate debt. The announcement by PCI is in line with raisings announced by the **Metrics Master Income Trust (MXT)** and the **Qualitas Real Estate Income Fund (QRI)** earlier in the year as discounts amongst fixed interest LITs have shifted to a premium over the last 12 months.

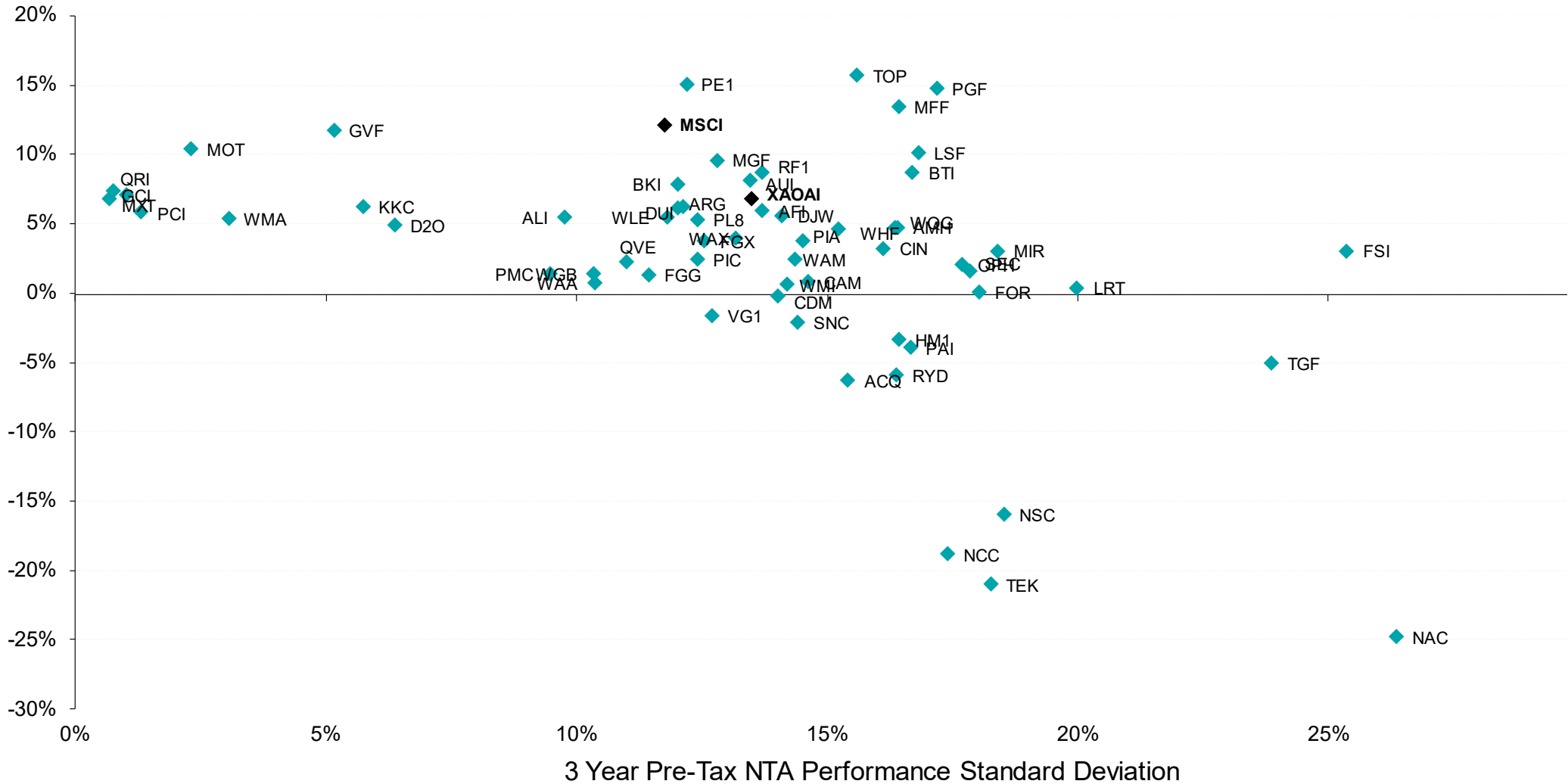

Chart 1: 3 Year Pre-Tax Performance v Standard Deviation



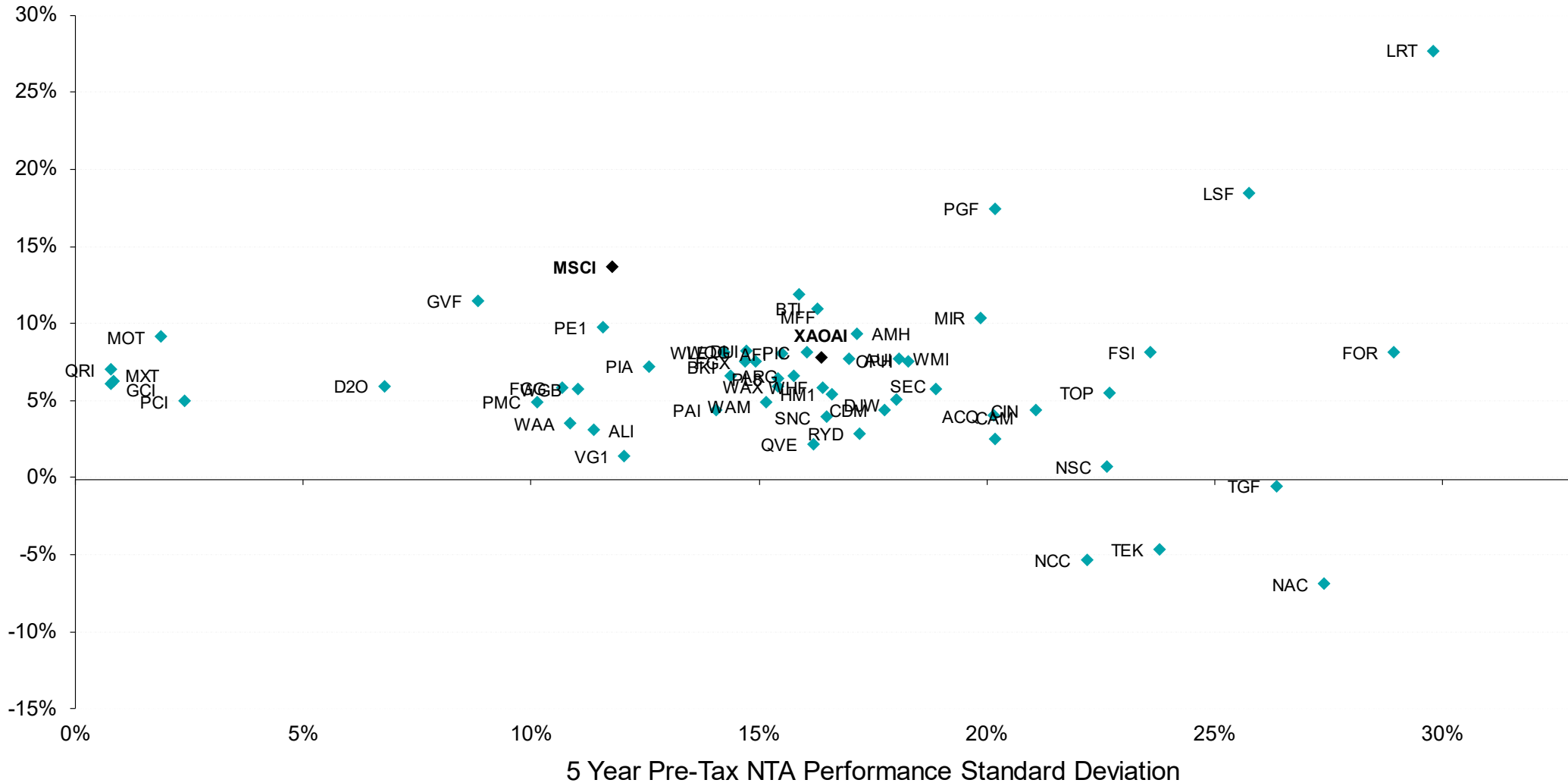

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation



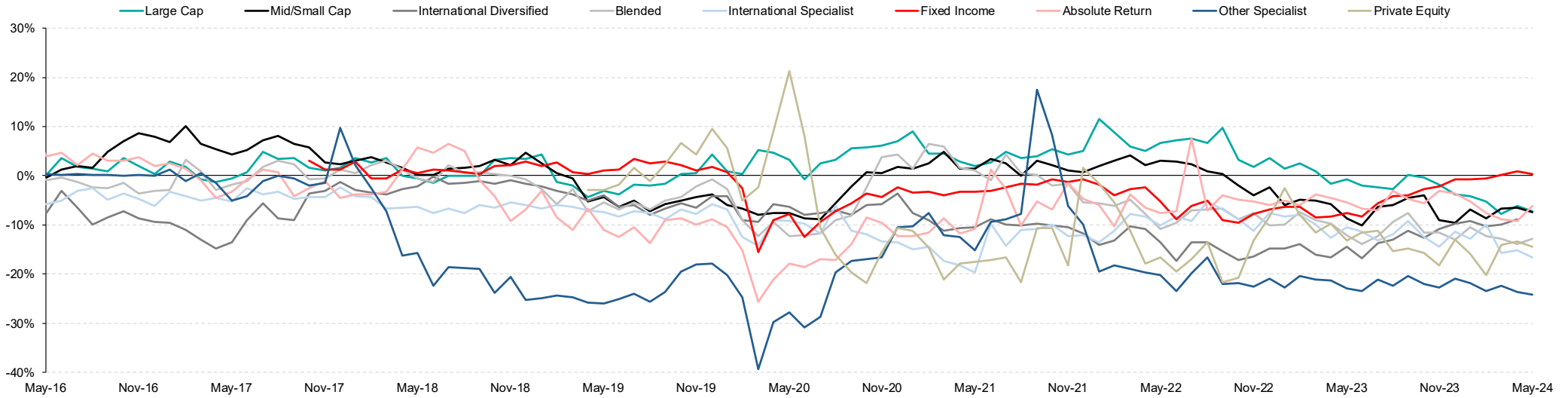

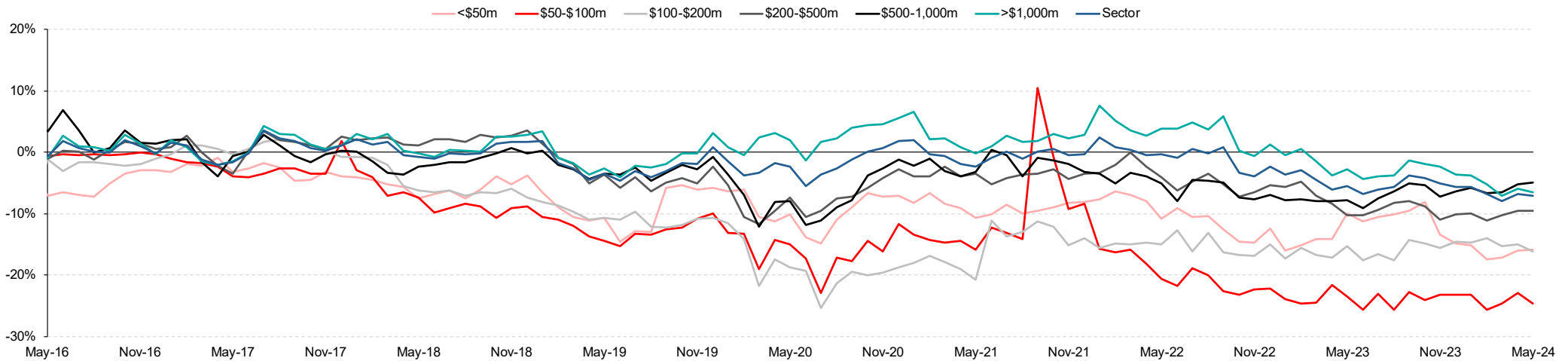

Chart 4: Premium/Discount by Market Capitalisation Band (Mkt Cap Weighted)

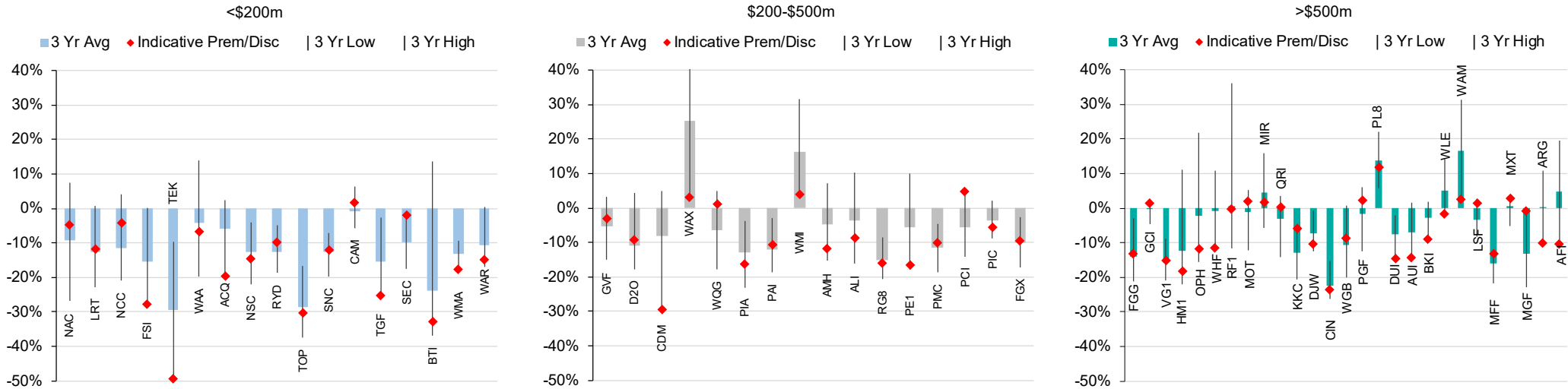

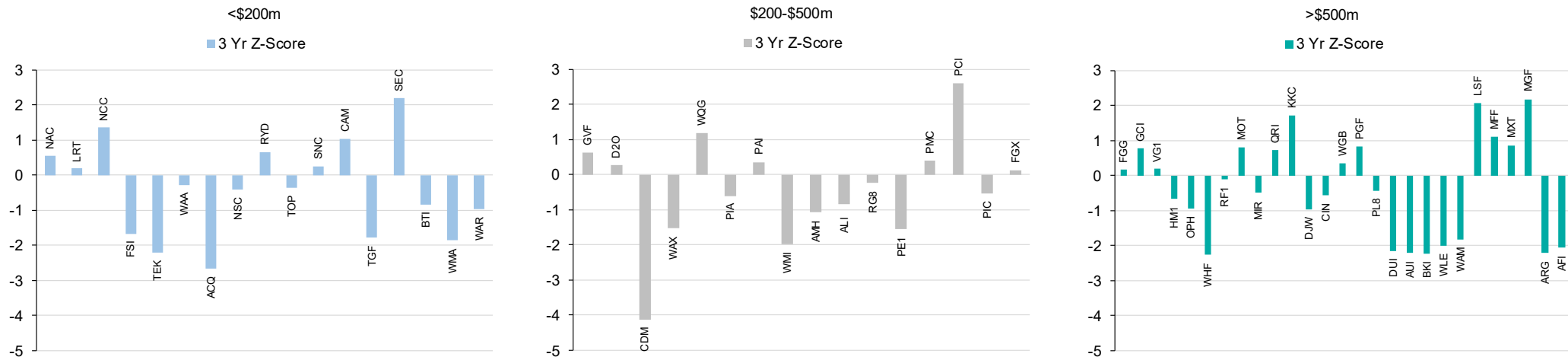

Chart 6: Standardised Premium/Discount by Variance Around Mean (Across Market Capitalisation Band)

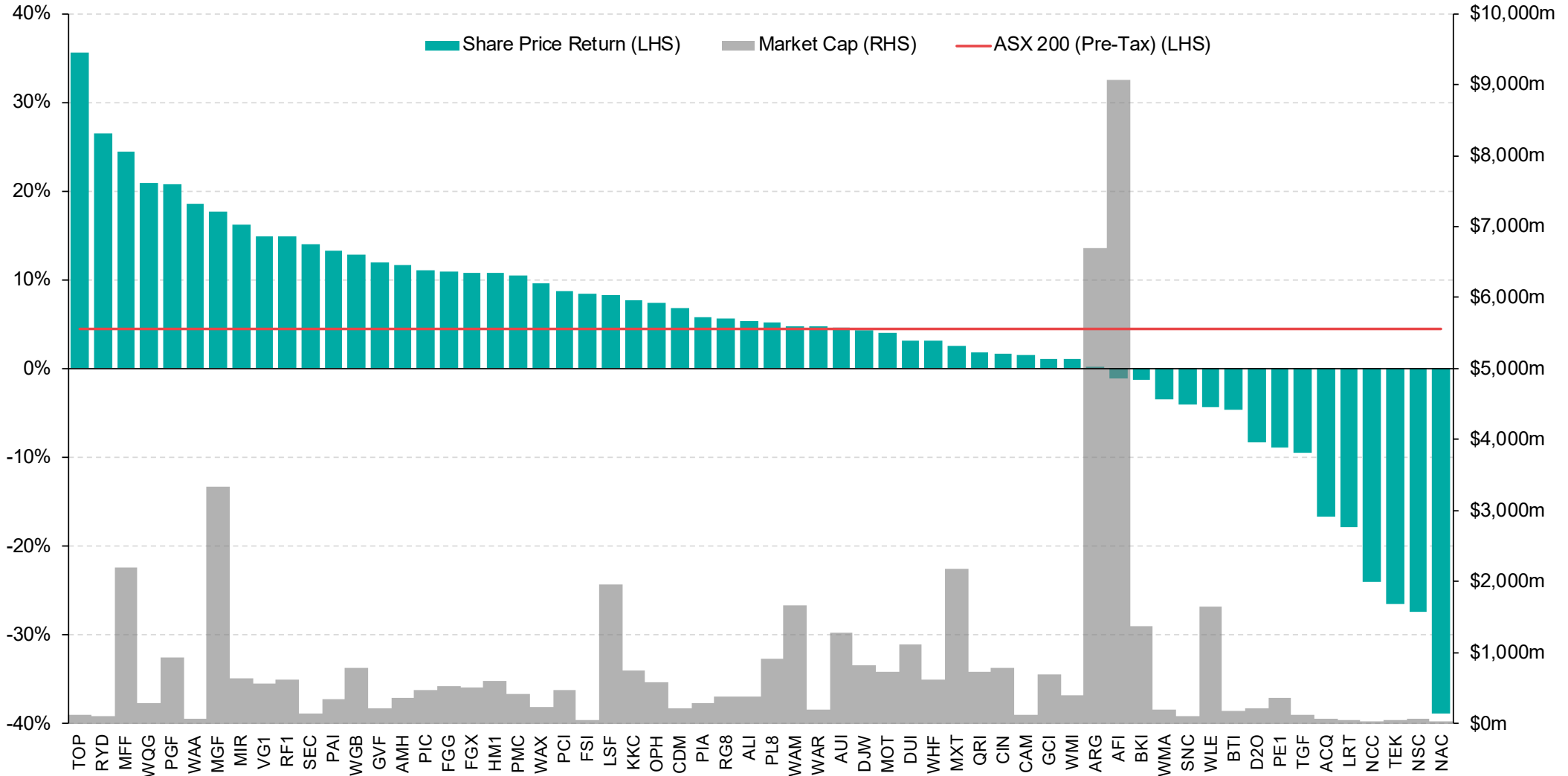
