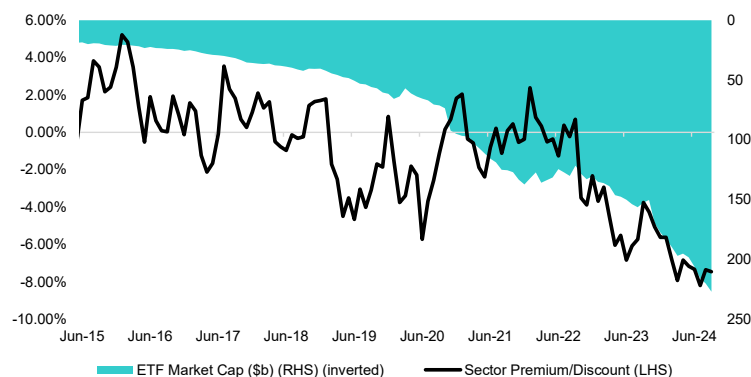

Dividend Coverage

With flows continuing to strengthen in the Exchange Traded Fund (ETF) market, many product issuers have introduced ETFs which are designed to provide yield enhancement over the underlying index, providing investors with a stream of frequent distributions. Whilst flows into these products have been strong, led by the **Vanguard Australian Shares High Yield ETF (VHY)** which has seen \$680 million in net inflows over the last 12 months, what remains often overlooked is dividend sustainability, or predictable dividend payments are moving forward. Many LICs offer similar income paying characteristics to ETFs combined with the ability to smooth out dividends, the payment of franking credits and an active management overlay. This is due to the unique structure of LICs, given they can elect to distribute profits they generate to shareholders as dividends, or alternatively accumulate excess earnings in a profit reserve, holding on to earnings to ensure a smooth dividend stream can be paid to shareholders even during periods where earnings can be less consistent.

Figure 1 - LIC Trading Premium/Discount vs ETF FUM (\$b)

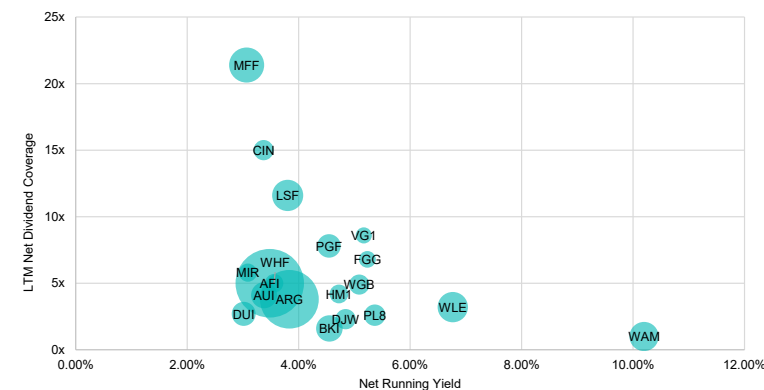

Our dataset brings together dividend coverage data as of 30 June 2024, by accounting for the reported dividend reserve across LICs in our peer group against dividends declared in the prior 12 months (excluding specials). Dividend coverage data is shown in Figure 2, reflecting the sustainable dividend paying capacity for many large-cap LICs, including **MFF Capital Investments Limited (MFF)**, **L1 Long Short Fund Limited (LSF)** and **PM Capital Global Opportunities Fund Limited (PGF)**.

Conversely, whilst **WAM Leaders Limited (WLE)** and **WAM Capital Limited (WAM)** trade on relatively high running yields, both LICs report net dividend coverage of less than 3 times and gross dividend coverage of less than 1 times, reflecting lower sustainability. This is reinforced by the recent reduction in the franking credits distributed by WAM, reducing the franked portion from the dividend from 100% to 60%. Overall, managers aim to deliver a steady-stream of growing, fully-franked dividends to their investors given a greater appetite by market participants. Often, reactive changes to dividend policy and inconsistent dividend payments can result in negative sentiment over listed funds, with managers acutely aware of the relationship between the consistency of dividend payments and the emergence of trading discounts.

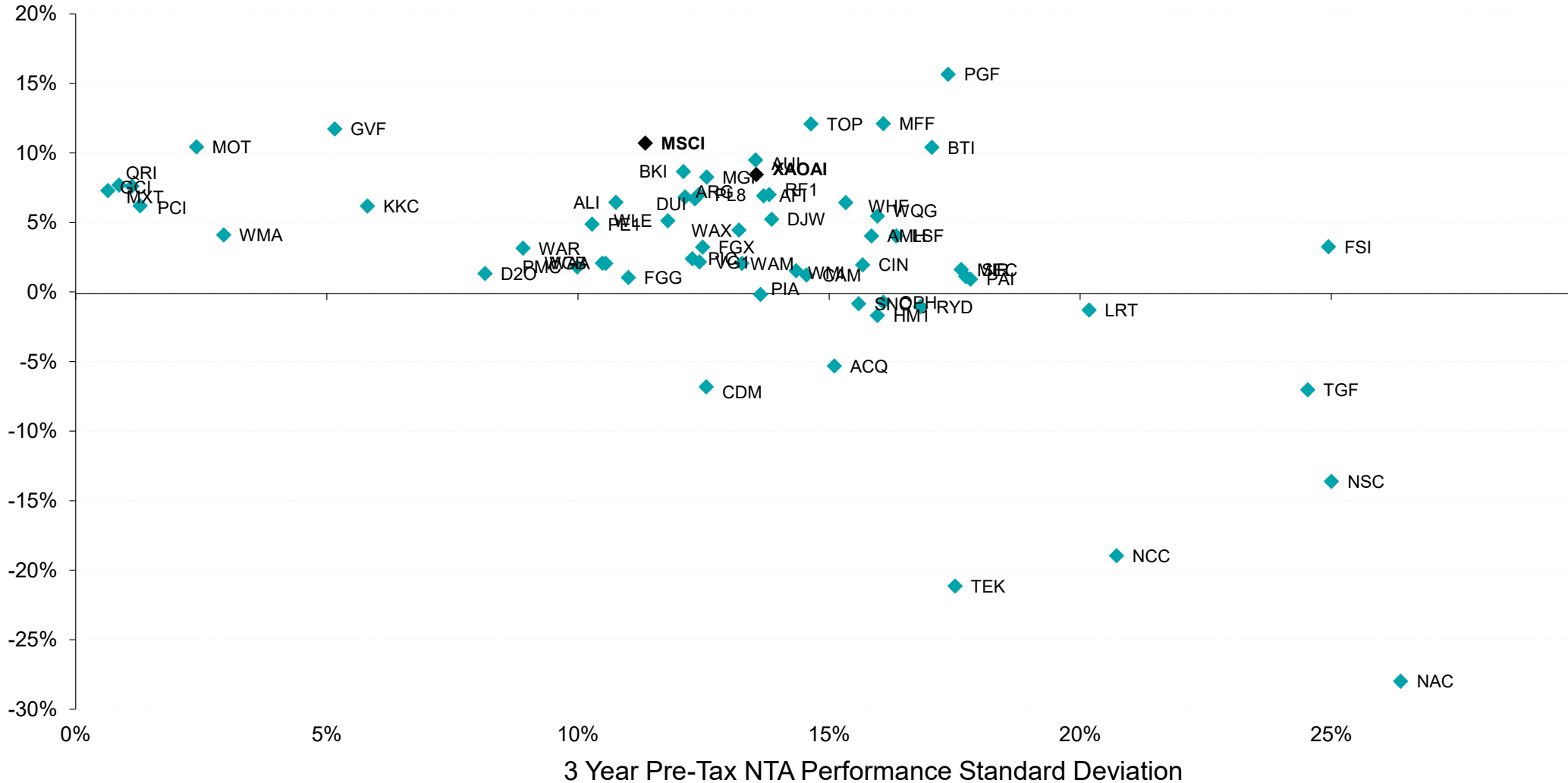

Chart 1: 3 Year Pre-Tax Performance v Standard Deviation



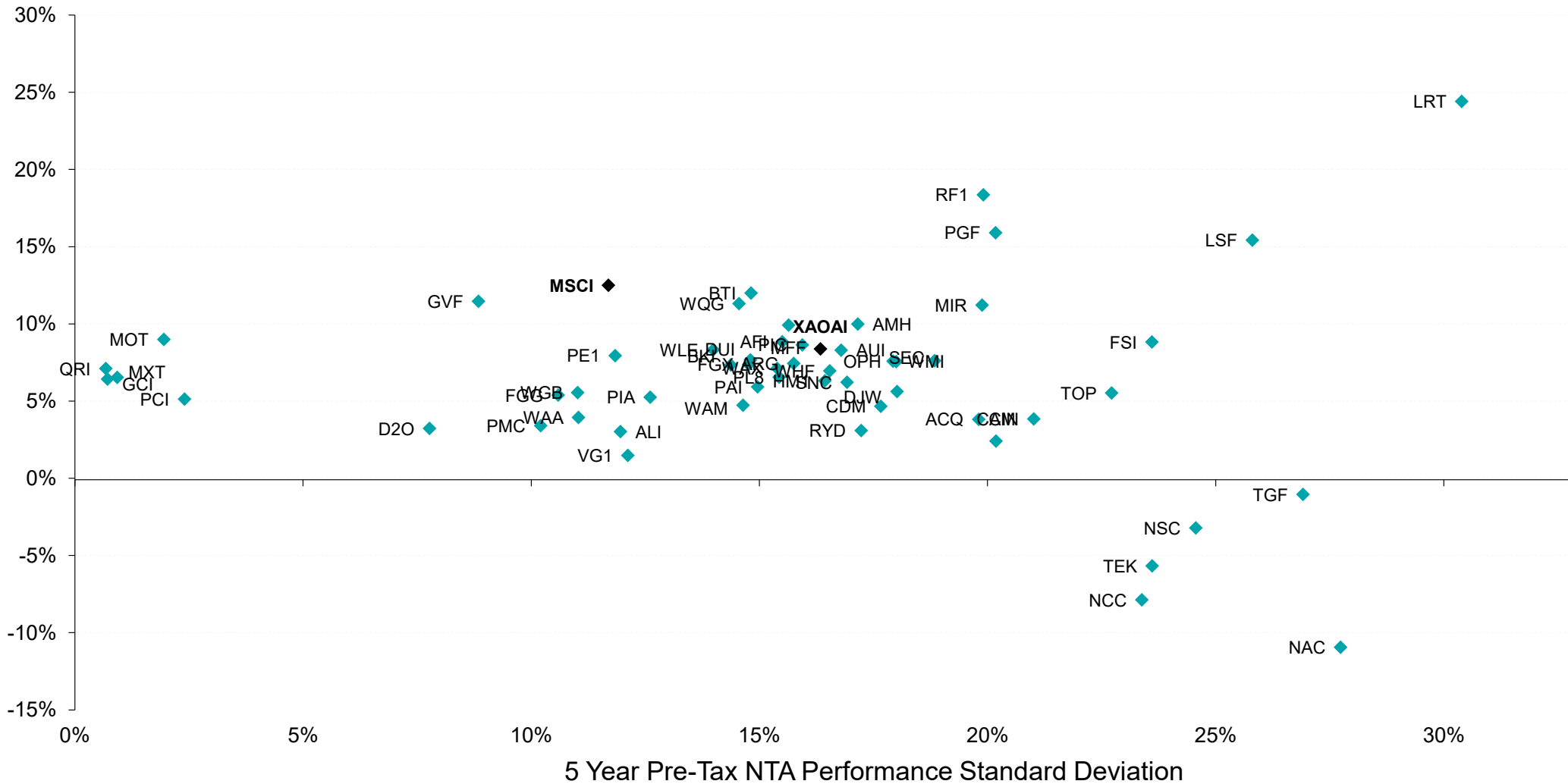

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation



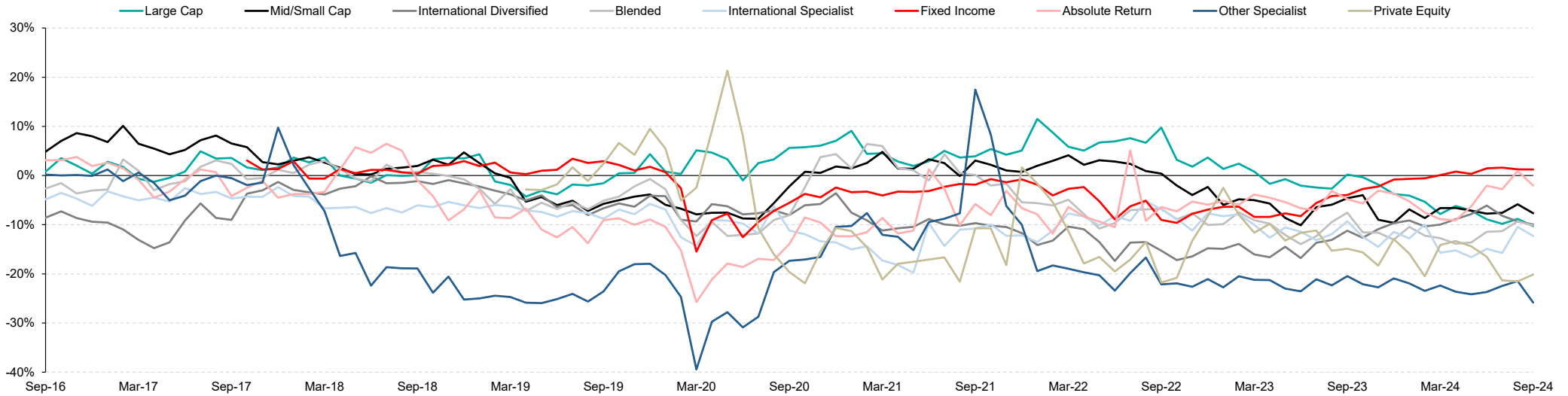

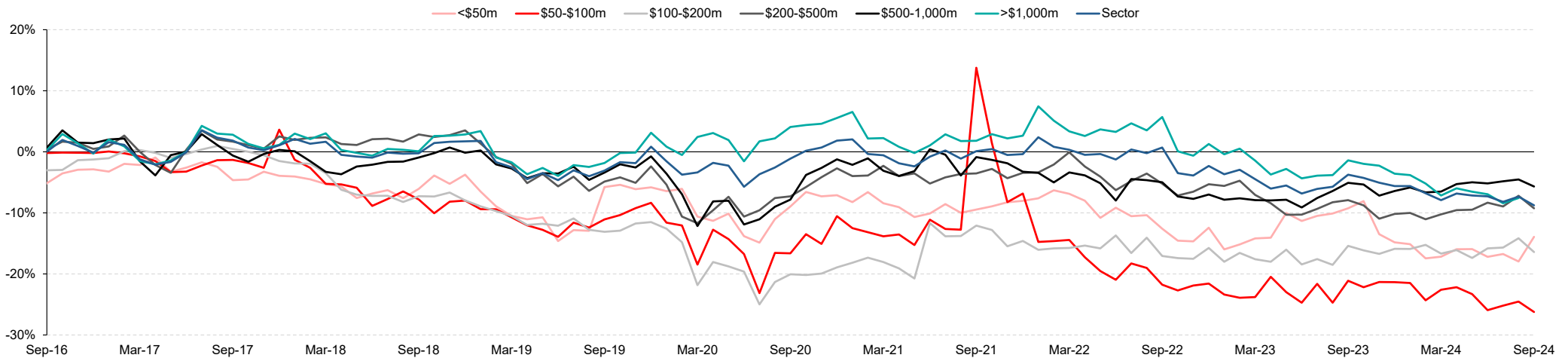

Chart 4: Premium/Discount by Market Capitalisation Band (Mkt Cap Weighted)

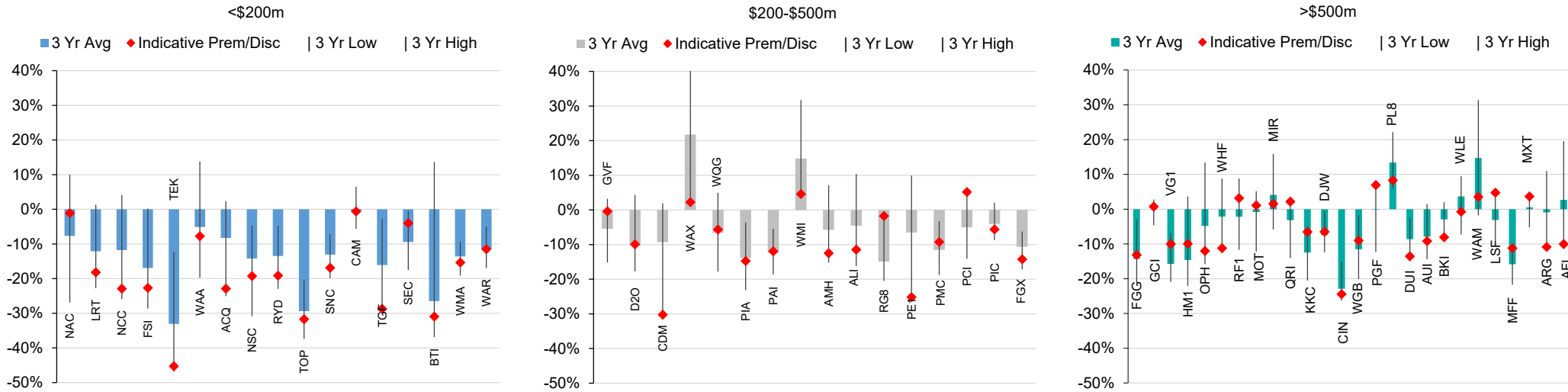

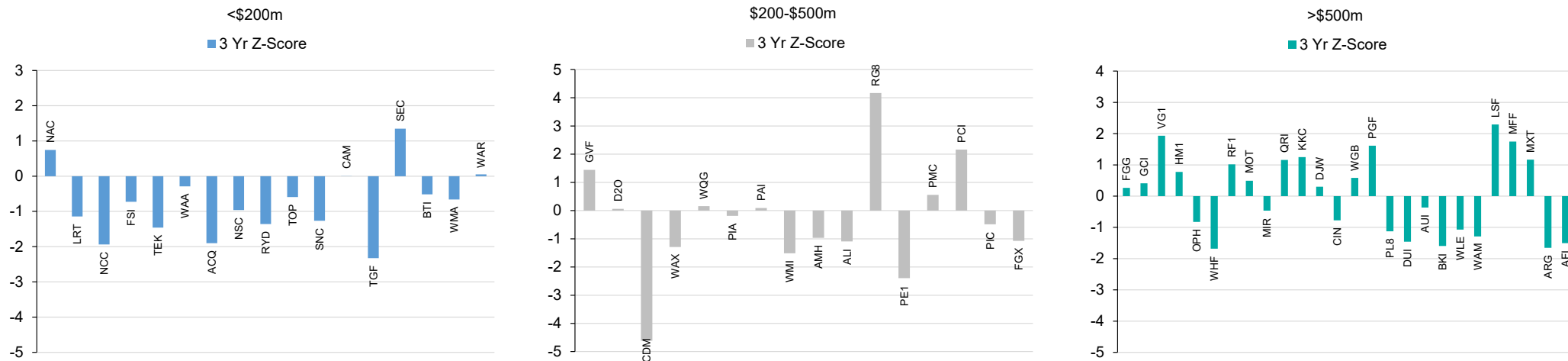

Chart 6: Standardised Premium/Discount by Variance Around Mean (Across Market Capitalisation Band)

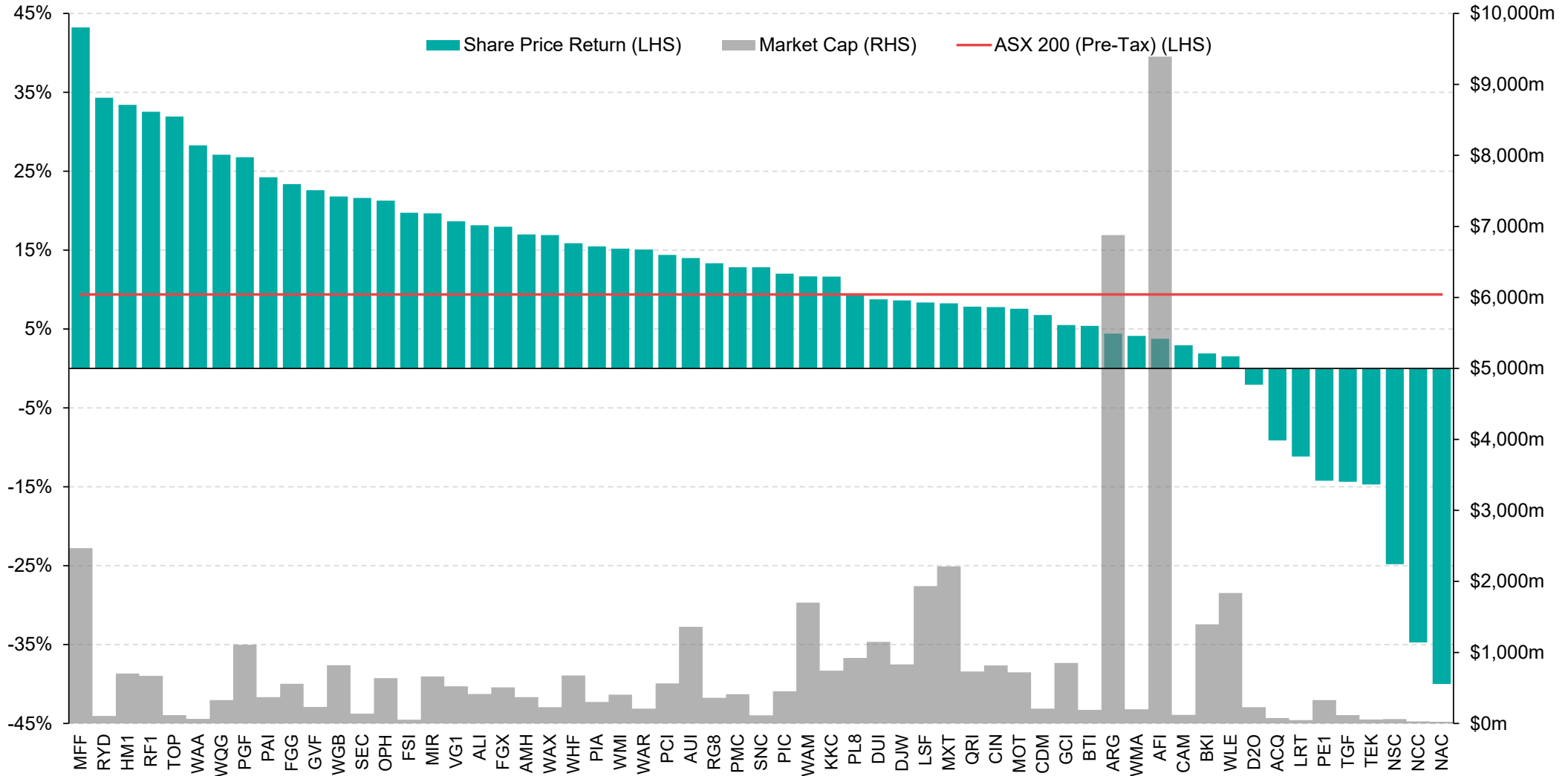
